

General Conditions & Exclusions

This Service Plan is available to all customers who purchase their a/c systems services from us during the term of the Plan and whose payments are in accordance with our payment and credit terms. The Service Plan becomes effective after payment has been received and our inspection and approval of your heating system.

1. The term of the Plan is for (1) one year and will re-new automatically every year unless terminated by either the customer or Company. No credit will be issued if the Plan is canceled before the expiration date.
2. Repairs or services not covered by the Plan will be performed and charged to the customer at prevailing rates.
3. The Service Plan does not cover labor or materials to repair damage to the a/c system or residence caused by the customer's neglect such as blown fuses or other failure of electrical system, improper thermostat settings or faulty thermostat, having ac system switches in the "OFF" position, debris build up in the air or venting systems and other causes related to the improper operation or maintenance of the ac system by the customer. Damage, repairs or replacement of parts or components cause by Acts of God, fire, flood, freezing, storm or weather conditions, power loss or surges, water damage and fuel flow problems due to outside fuel storage are not covered by the Plan.
4. Company will provide service as soon as practical, during regular business hours under normal conditions or on an emergency basis if necessary. Company will not be liable for any delay or failure to provide service due to conditions beyond its control such as Acts of God, labor disturbances or strikes, unavailability of mechanics or parts, failure or interruption of customer's electricity, inaccessibility of the heating system, storms, floods or other severe weather conditions, or government laws or regulations.
5. The Service Plan only covers a/c system parts and components specified in the Plan. Examples of components not covered by the Plan include related piping, patches or unstable conditions, humidifiers, heat pumps, heat exchangers, hot water heating systems (unless purchased separately) and heating systems. The Plan does not cover environmental clean up, property damage, waste disposal services or other damages or losses caused by a tank leak or system failure.
6. Customer agrees to release and hold Company harmless from all claims related to losses, costs, or damage to personal or real property caused by fire, explosion, flood, freezing, power loss or surges, and premises left unattended. Customer agrees that Company shall not be liable for any incidental, special or consequential damages incurred by customer or by third parties.
